### Morongo Indian Health Clinic Replacement Project

BRG is preparing an Environmental Assessment (EA) for the Riverside-San Bernardino County Indian Health, Inc. to replace and expand the existing health care facility on the Morongo Indian Reservation in Banning, California. The Bureau of Indian Affairs (BIA) will utilize the EA to secure a lease of a ten (10)acre parcel on the northeast corner of Hathaway Street and Hoffer Street.



Along with the site lease, the Proposed Action includes the construction and operation of a replacement health clinic (50,000 SF), landscaping, parking, lighting, an outdoor covered area, and new curbs, gutters and a new driveway from Hoffer Street. Several public roadway and utility improvements are also incorporated into the Proposed Action, including the northward extension and expansion of North Hathaway Street; the eastward extension of North Hoffer Street to Morongo Road; and, the relocation of the existing Morongo Guard Shack and gated Reservation entrance. Additionally, the EA will address demolition of the existing Morongo Indian Health Clinic, while protecting the historic Tribal jail structure.

As part of our efforts, BRG's team is preparing the air quality, biological resources, cultural resources and noise technical analyses. In compliance with Section 106 of the National Historic Preservation Act, we are working with the Morongo Tribal Historic Preservation Officer to obtain concurrence on the Area of Potential Effect, potential effects on historic resources, and potential mitigation.

BRG is also responsible for coordinating BIA's staff reviews of the EA, distribution of the EA, and preparation of the Finding of No Significant Impact (FONSI), along with all NEPA-required public notices. The Draft EA along with the Final EA/FONIS are scheduled to be complete in first and second quarters of 2022, respectively.

### Cahuilla Indian Health Clinic Replacement Project

BRG prepared an Environmental Assessment (EA) and Finding of No Significant Impact (FONSI) for the Riverside-San Bernardino County Indian Health, Inc. to replace a health care facility on the Cahuilla Indian Reservation in Anza, California. The Bureau of Indian Affairs (BIA) utilized the EA to secure a lease of a three (3)-acre parcel located south of State Route 371 (SR-371)



and east of Puckit Drive. The existing Cahuilla Santa Rosa Health Clinic is located at 39100 Contreras Rd #C, Anza, CA 92539 within leased space in a commercial building.

The Proposed Action included the construction and operation of a replacement health clinic (11,600 SF), a stormwater retention basin, septic system, landscaping, parking, lighting and a new vehicular driveway from SR-371. The purpose of the Proposed Action was to provide improved health care services and assure that comprehensive, culturally acceptable personal and public health services are available and accessible to American Indian people residing in Riverside and San Bernardino Counties.

The EA was prepared in compliance with NEPA (42 United States Code §4321 et seq.), the Council on Environmental Quality Guidelines for Implementing NEPA (40 CFR Parts 1500-1508), as well as the BIA's NEPA Guidebook (59 Indian Affairs Manual 3-H). Consistent with the BIA's overall efforts to streamline the NEPA process, the EA met the page and time limit requirements for environmental compliance documents established under Executive Order 13807 and Secretarial Order 3355. It evaluated potential impacts to land resources, water resources, air quality, living resources, cultural and paleontological resources, socioeconomics conditions, important farmlands, noise, transportation, resource use patterns, hazardous materials, community infrastructure, and visual resources. Modifications were incorporated in the Proposed Action to ensure that project-related effects would not be significant.

BRG prepared the air quality, biological resources and cultural resources technical analyses in support of the EA. In compliance with Section 106 of the National Historic Preservation Act, we also worked with the Morongo Tribal Historic Preservation Officer to obtain concurrence on the delineation of the Area of Potential Effect and the Finding of No Effect.

# Soboba Indian Health Clinic Replacement Project



BRG prepared an Environmental Assessment (EA) for the Riverside-San Bernardino County Indian Health, Inc. to replace a health care facility on the Soboba Indian Reservation in San Jacinto, California. The Bureau of Indian Affairs (BIA) utilized the EA to secure a lease of an 8.3-acre project site located immediately south of Soboba View Drive and southwest of Soboba Road (Proposed Action). The EA "tiered-off" the 2013 Final Environmental Impact Statement (FEIS) for the Horseshoe Grande Fee-to-Trust Project. This FEIS evaluated the consequences of the Soboba Band of Luiseño Indians' proposal to convey 34 parcels, 534.91± acres of Tribally-owned property to Federal trust status along with a proposal to develop 55 acres of the Project Site into a destination hotel/casino complex. The Health Clinic site was within the area covered by the FEIS.

The EA was prepared in compliance with the National Environmental Policy Act (NEPA) (42 United States Code §4321 et seq.), the Council on Environmental Quality Guidelines for Implementing NEPA (40 CFR Parts 1500-1508), the BIA's NEPA Guidebook (59 Indian Affairs Manual 3-H), Executive Order 13807, and Secretarial Order 3355.

The clinic and commodities building will provide improved health care services and assure that comprehensive, culturally acceptable personal and public health services are available and accessible to members of federally recognized American Indian and Alaskan Native tribes residing in Riverside and San Bernardino Counties. These services are needed to maintain and promote the health status and overall quality of life of eligible persons and their families. The project consists of a single-story replacement health clinic building (44,000 SF), a single-story commodity distribution building (12,300 SF), along with parking for 373 vehicles, landscaping, lighting, utilities, and storm drain facilities. The Project will connect to existing water, sewer, electrical, and natural gas lines within Soboba Trails Road, an existing two-lane private road. Vehicle access to the site will be provided from Soboba Road via Soboba Trails Road.

BRG also prepared the FONSI and the Notice of Availability (NOA) of the Draft EA. We were also responsible for ensuring the NOA's publication in the local paper of record. An Air Quality Technical Report for the project also was prepared.

# **Torres Martinez Indian Health Clinic Replacement Project**



BRG prepared an Environmental Assessment (EA) and Finding of No Significant Impact (FONSI) for the replacement of a health care facility on the Torres-Martinez Desert Cahuilla Indian Reservation in Thermal, California (May 2017). The Bureau of Indian Affairs (BIA) used the EA to secure a lease of the 2.5-acre Project site located south of 66th Avenue and west of Martinez Road near the Torres-Martinez Tribal Administrative Complex. We also prepared an amendment to the EA and FONSI in June 2019 for the Indian Health Service Department to secure financial assistance for the clinic under the Small Ambulatory Grant Program.

The existing Torres-Martinez Health Clinic, located at 66-735 Martinez Road, was established in 1971 and offers a variety of nonemergency medical and community services within a single story 4,200 SF structure. The replacement clinic consists of an 11,60 SF facility on a 2.5 acre parcel south of 66<sup>th</sup> Avenue, and west of Martinez Road, near the Torres-Martinez Desert Cahuilla Indian Administration Complex. The Project also includes parking spaces, landscaping and a pedestrian path to connect the proposed clinic to the adjacent senior housing center.

The Project site is located within the Torres Martinez Historical District (CA-RIV-1292). For this reason, our team prepared a Cultural Resources Monitoring Plan and NAGPRA Plan of Action and a Curation Plan. The purpose of these documents was to ensure that any cultural materials recovered during construction will be respectfully handled and provided to the Torres Martinez Band of Cahuilla Indians. Construction monitoring for the clinic was completed in August 2021. monitoring for the clinic.

# **Rincon Reservation Comprehensive Master Plan**



BRG prepared a comprehensive Master Plan for the Rincon Band of Luiseño Indians' Reservation, using an inclusive approach that encouraged tribal member participation and ongoing coordination with the tribal government administration and staff. The first phase of the planning effort included conducting a tribal census and opinion survey, which achieved a high percentage of response from the members, allowing BRG to provide updated population and housing needs forecasts.

BRG prepared a topographic base map from available databases and converted that into a comprehensive Geographic Information System (GIS) database. BRG's multidisciplinary environmental survey of the reservation, also recorded in GIS format, included biological and cultural resources, existing land uses, surface water resources, flood hazard zones, soils, and geological hazards, including steep slopes.

The master planning included an extensive community outreach and involvement program that used focus group meetings with tribal members to identify Master Plan goals, objectives and topical issues. The focus group discussion centered on issues identified in BRG's earlier opinion survey. To facilitate attendance, meetings with tribal members were held on the reservation and in several locations throughout the area. The results were reported to the Tribal Council and were incorporated into the Master Plan.

The resulting Master Plan presented the Land Use Plan and supporting environmental and land use resource information. It includes a detailed identification of Goals and Strategies which outline the Band's vision for the Reservation. Each goal is accompanied by specific strategies, which form the basis for each plan element's Action Plan. The Master Plan includes: an Introduction; Background Information; Goals and Strategies; and elements for Cultural and Natural Resources and Quality of Life, Tribal Resources and Environmental Protection, Utility Services, Roads and Access, Public Safety, Housing, Economic Development, and Implementation & Enforcement.

### Rincon Reservation Comprehensive Master Plan Update



Between 2016 and 2017, BRG prepared a update to the Rincon Indian Reservation Master Plan, which BRG originally prepared in 2008. The updated Master Plan emphasized the Rincon Band's long-range vision for the reservation. This vision focused on maintaining the rural ambiance of the reservation while enhancing the quality of life of residents.

Part of this endeavor by the Rincon Band of Luiseño Indians was to consolidate and reacquire parcels within the reservation owned by non-members. BRG researched all parcels that had been acquired since 2008 to determine if there were any resources that may be inconsistent with proposed uses and updated all Master Plan figures to include these new parcels.

The Master Plan was also updated to clearly express the Rincon Band's intention to protect natural resources on the reservation, as well as the health and safety of residents. BRG updated the Cultural Resources section to clarify how to protect cultural resources and the Band's heritage throughout the reservation. The Tribal Resources, Waste Management, and Esthetics section was updated to include clearer guidelines for waste disposal and for protection of reservation water resources and environmentally sensitive habitats conducted a census of tribal members, residing both on and off the reservation. The resulting data were important to identifying needs and projecting trends underlying the Master Plan's goals and strategies. BRG also conducted a survey of tribal members, to obtain comprehensive information on issues of concern and priorities for action, focused particularly on economic development, to be addressed in the Master Plan Update.

For the previous Master Plan, BRG prepared and converted the topographic base map into a comprehensive GIS database. In the update, BRG revised figures documenting biological and cultural resources, existing land uses, surface water resources, flood hazard zones, soils, and geological hazards, including steep slopes.

#### Land Use Master Plan

BRG prepared a Land Use Master Plan for the Sycuan Band of Diegueno Indians' Reservation. The Master Plan was developed in consultation with tribal members and staff and was based on preservation of sensitive environmental and tribal resources, in the context of existing development and facilities on the Reservation. A primary goal of the Master Plan was to estimate the total number of housing units the Tribe will need over a 20-year planning period, based on population and housing projections prepared by BRG. The Master Plan consisted of three sections: a recommended Land Use Plan, Development Opportunities and Constraints, and Population And Housing Projections. The Master Plan was adopted by unanimous vote of the General Council.

#### Sycuan Parking Structure Tribal Environmental Impact Statement

BRG prepared a Tribal Environmental Impact Statement (TEIS) and obtained regulatory permits for the parking structure. The project consisted of infrastructure improvements required to resolve public safety and flooding issues. Specific improvements included new 2,000-space parking structure with dedicated pedestrian and automobile ingress and egress. The project also included a widening of Casino Way to enhance pedestrian safety, provide a safer access road and flood improvements to safely convey the 100-year flood event. BRG prepared the TEIS in compliance with the Sycuan Band's Environmental Protection Ordinance adopted pursuant to its Class III Gaming Compact with the State of California. In addition, BRG prepared and processed regulatory permits for the project, including an Environmental Protection Agency Section 401 certification and a US Army Corps of Engineers Section 404 Permit.

# Viejas Casino & Resort Phase 3 Project (Hotel)



In 1999, the Viejas Band of Kumeyaay Indians (Tribe), a federally recognized Indian tribe, and the State of California (State) entered into a Tribal-State Class III Gaming Compact (Compact) pursuant to the Indian Gaming Regulatory Act of 1988. Amended in 2004 and 2014, the Compact requires the preparation of a tribal environmental impact report (TEIR) to analyze potentially significant off-reservation environmental impacts of any new, renovated, expanded or modified gaming facility.

BRG prepared the TEIR for the Viejas Casino & Resort – Phase 3 for the Tribe. The Project consisted of construction and operation of a 170 room, five-story hotel (215,000 SF), as well as demolition and reconstruction of a portion of the existing casino. A new bus terminal and bus drop off area were constructed near the Casino's northwest entrance and a new casino walk was added to provide access to the new hotel.

In addition to preparing the TEIR, BRG prepared all TEIR required notices including the Notice of Preparation, Notice of Availability (NOA), and Notice of Completion, and filed them with the State Clearinghouse, the State Gaming Agency, the California Department of Justice, the Office of the Attorney General and the County of San Diego. BRG also distributed the TIER and published the NOA in a newspaper of general circulation. Additionally, BRG facilitated government-to-government negotiations with the County as required by the Compact.

The Project site is located in the vicinity of Viejas Creek, an area designated as critical habitat for the federally endangered arroyo toad and with suitable habitat for the federally endangered least Bell's vireo and southwestern willow flycatcher. BRG prepared the Biological Technical Memorandum which identified avoidance measures to ensure that the Project would not result in significant direct, indirect, or cumulative impacts to these sensitive biological resource.

BRG was able to resolve groundwater issues by working closely with the County's groundwater specialist and the Tribe's Public Works Division. Although the TEIR found no significant off-reservation environmental effects would occur and no mitigation measures were required, various avoidance and minimization measures were included to ensure consistency with the Intergovernmental Agreement between the County of San Diego and the Tribe.

BRG ensured the TEIR was prepared in accordance with the updated Tribal Compact and facilitated successful negotiations with the County of San Diego, enabling a smooth public review process and simple revisions to the Intergovernmental Agreement. The TEIR was completed on time and within budget.



# 111 Calexico Place Specific Plan EIR



BRG prepared an environmental impact report for the 111 Calexico Place Specific Plan, a 232-acre site in the City of Calexico. The proposed project includes a Class III Tribal Gaming Casino Facility and Hotel, surrounded by retail, restaurant, office, and public facilities uses.

The project required discretionary actions by the Calexico Planning Commission and City Council, including approval of a Specific Plan, General Plan Amendment, Tentative Tract Map, Development Design Approval, and a Development Agreement between the City of Calexico and the applicant (Hallwood Calexico Investments, LLC). The applicant was a joint venture comprised of the Viejas Band and a private party. The casino complex would be owned and operated by the Manzanita Band. BRG supported the Law Office of Cary Lowe in obtaining the required project land use approvals.

A fee-to-trust annexation to tribal lands of the Manzanita Band was proposed for 60 acres of the 232-acre site for Class III gaming, subject to approval by the Bureau of Indian Affairs. BRG prepared a separate environmental impact statement for the Bureau of Indian Affairs proceedings.
